Profile

With a Ph.D. and M.A. in social history from PUC-SP (partially completed at the University of Chicago) and specializations in Data Science, Regulatory Compliance and Corruption, my scholarly works have earned me accolades, scholarships, and fellowships, including two books in top-tier university libraries in the US, and chapter published by Cambridge University Press. I am a Co-Founder of the first North American hub for social scientists researching corruption, and have lectured several extension courses, with 30+ invited talks and paper presentations, and organized several international conferences. My "Corruption Talks!" Podcast interviews influential academics, and I'm frequently consulted on public policy, including by the Washington Post.

My research proposes a novel perspective on the anticorruption agenda, which I see as a critical part of neoliberalism driving its expansion and survival when its prescriptions fail. Through extensive analysis of documentation, I argue that the crucial role of morality embedded in the anticorruption agenda works also to attack any type of State intervention, depicted as inherently corrupt due to its supposed "lack of technical components" - portraying itself of purely technical . This aversion to politics fuels support for minimal state intervention and expansion of private capital. However, this discourse also enables the rise of anti-democratic agendas and "anti-corruption heroes," as seen throughout Brazilian History.
